- 1. Actual construction will be performed by a licensed and insured contractor.
- 2. All appropriate permits and City/Township inspections must be obtained and paid for by the Co-owner.
- 3. All applicable codes and regulations will be followed.
- 4. All costs for this modification shall be the sole responsibility of the co-owner.
- 5. Any maintenance costs incurred by the Association as a result of this modification will be at my/our expense.
- 6. I/We understand even after approval, I/We shall be responsible for all damages to any other units and their contents or common elements resulting from this alteration. I/We accept responsibility for and fully indemnify and hold the Association harmless from any and all damages or costs of any repair, replacement or maintenance of any other Common Elements necessitated or caused by this alteration.
- 7. I/We understand that, should any legal, regulatory agency require, at any time in the future, modifications to this variance, they will be done at my/our expense.
- 8. All future maintenance, repair and/or replacement shall be the sole responsibility of the current and future Owners of the unit.
- 9. I/We understand that it is my/our responsibility to advise future assigns and/or owners of this unit, of all modifications and their responsibility for same.
- 10. At the discretion of the Board of Directors this modification/alteration may be recorded at Oakland County records for purposes of ensuring disclosure, upon any future transfer of ownership, the co-owner's responsibilities as they relate to this alteration/modification. In the event of recording, all associated fees will be paid by the Association and charged back to the co-owner.
- 11. Master Deed, Article IV, Section 2A. Co-owner's Responsibilities, (3) Co-owner Additions, Modifications:
  - Co-owner improvements, additions or modifications, even though approved by the Association, shall not be considered Limited or General Common Elements in any case, and shall be the complete responsibility of the Co-owner. Should the Association require access to any elements of the Condominium which necessitates the moving or destruction of all or part of any such addition or modification, all costs, damages and expenses involved in providing access and restoring the addition or modification shall be borne by the Co-owner.
- 12. I/We have read all applicable sections of the Master Deed and Bylaws and I/we understand same.
- 13. I/We agree to notify the management company when the modification has been completed.
- 14. An inspection of the completed modification shall be conducted to ensure compliance with all appropriate Association restrictions and conditions.
