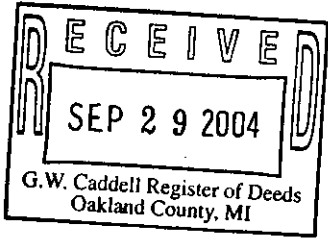

**SECOND AMENDMENT TO MASTER DEED
OF
MOON LAKE CONDOMINIUM**

WHEREAS, Moon Lake was established as a residential condominium project in the Township of West Bloomfield, County of Oakland, State of Michigan, by the recording of a Master Deed on July 12, 1989, in Liber 10976, Pages 795 through 868, and by the recording of a First Amendment to Master Deed on August 28, 1989, in Liber 11040, Pages 475 through 484, Oakland County Records, and was designated as Oakland County Condominium Subdivision Plan No. 620; and,

WHEREAS, Moon Lake is administered by Moon Lake Condominium Association, the Michigan non-profit corporation designated to administer the affairs of the project pursuant to said Master Deed; and,

WHEREAS, amendments to the Restated and Amended Condominium Bylaws (Exhibit A to the Master Deed) were duly proposed, adopted and approved by the requisite majority of the co-owners, in accordance with Article XVI of the Condominium Bylaws for the purpose of generally updating same;

NOW, THEREFORE, the Amended and Restated Bylaws (Exhibit A to the Master Deed) supersede and replace the Condominium Bylaws that were attached as Exhibit A to the Master Deed and any amendments to that document adopted prior to the date of this amendment.
